Annual FY17 Benefit Choice Period: May 1 - May 31, 2016

The annual benefit choice period will be May 1-31. During this time, you have the opportunity to make changes to your existing benefit plans. Changes will be effective July 1, 2016.

If you're changing your benefits

Submit the enclosed FY2017 Benefits Election Form to our office by the end of business **May 31, 2016**.

Not changing your current benefits?

Then you're finished with your enrollment this year!

FY17 benefits remain the same during contract negotiations

The following will remain the same until contract negotiations are final:

- Dependent premiums
- Life insurance rates
- Dental rates
- Plan design

Once the contract is settled, members will receive information about changes and a second benefit choice period.

Mailings and information

In addition to this newsletter and the FY2017 Benefit Choice Elections Form, you will receive the "A Message to Plan Members" mailer from CMS.

This mailer is directed to all members and contains the key changes and information you need to know for the benefit choice election period, including the service area map.

Total Retiree Advantage Illinois (TRAIL) Medicare Advantage program

If you and your covered dependents become eligible for enrollment in Medicare Parts A and B *and* meet all the criteria for enrollment in the TRAIL Medicare Advantage Program, you will receive an enrollment packet during the fall enrollment period. At that time, you will be required either to choose a Medicare Advantage Plan or to opt out of State coverage (health, behavioral health, prescription and vision coverage) with an effective date of Jan. 1, 2017.
